- 6. New Business
- (a) Running Brook Farms, Extension Request, Jan. 1, 2022 to Mar. 31, 2022
 It was noted RBF has a permit to process and grind during a 3 month period, January thru
 March. This has to be renewed every year. Stephanie Warren noted it sounds like they are
 going to process ash trees. She indicated a 100' Ash tree collapsed and fell on her house.
 Discussion followed regarding the Ash Borer and whether processing of this wood would spread
 it. The actual time for them to do this is four weeks between January and March. All material
 would be put in bins and then moved off site. Most of this wood is for fire wood. Chairman
 Lentz noted the area to the east was to be cleared which it is not. Warren noted her main
 concern is very specific with the Ash Borer tree. Chairman Lentz noted the Commission cannot

(b) Summer Hill Road Subdivision, Madison

Chairman Lentz noted this was sent to Planning & Zoning because the property abuts the Town of Killingworth, but it does not exit into Killingworth. It consists of 3 residential building lots. This will also be forwarded to RiverCog as its within 500 feet of another town.

(c) Election of Officers

Motion by Hogarty, second by Drew, to nominate Thomas Lentz as Chairman for the upcoming year. PASSED UNANIMOUSLY.

(d) Appointment of Zoning Enforcement Official Motion by McGuinness, second by Tobelman, to appoint Tom Hogarty as Interim ZEO. PASSED UNANIMOUSLY.

It was noted a ZEO candidate was interviewed today and is well qualified. He has extensive experience as ZEO and Town Planner. He is retired but would like to be involved in some way part time. Tom Talbot has worked in Hamden, New Haven and Wallingford. Hogarty noted he would endorse him as ZEO. Warren noted his resume was very impressive. First Selectwoman Gorski noted he was very impressive. She indicated she would issue a letter offering him the position and them the Board of Selectmen would appoint him as ZEO. The Inland Wetland Officer position will be appointed at a Board of Selectmen meeting.

First Selectwoman Gorski thanked Tom Hogarty for his service on the Commission as well as filling in as interim ZEO.

7. Zoning Enforcement Officer's Report

There was a brief discussion regarding CT Clinical Services Inc. which is a group home for mental disabilities, etc. There are 3 properties in town of interest, 3 single family homes on Parker Hill Road Ext. First Selectwoman Gorski noted this is well within the Zoning Regulations and will be announced at the next Board of Selectmen meeting. They are a for profit organization so the
