MINUTES

May 9, 2023

- A. The BOS took no action on the KAA [Killingworth Ambulance Association] request for increased capital ARPA funding. We will revisit the request in July.
- B. The BOS reviewed two-line items which are over in 22/23. Highway other basin cleaning is over budget by \$15K because the bid came in after the budget passed. 23/24 basin cleaning budget was revised with these increased costs. Compactor operations truck operation and repairs is over budget by \$13K due to emergency repairs to the roll-off.

Regina Regolo, Financial Director, distributed the April 2023 Financial Report prior to the meeting. R. Rimmer reviewed several line items. R. Regolo, via telephone, addressed inquiries of the Board.

Approve Invoice from The Source re: proposed town budget publication.

M. Couture **MOVED** to accept and approve as presented the invoice from The Source for the Proposed Town Budget Publication in the amount of \$1,875 for the May 4, 2023 Publication. A. O'Neill seconded the motion. Discussion: none. Voting in favor: R. Rimmer, A. Stirna, M. Couture, T. Amatrudo, S. O'Brien, and, A. O'Neill. Opposed: none. Abstentions: none. The motion was **carried**, 6-0-0.

Appointment of Auditor. M. Couture **MOVED** to appoint Hoyt, Filippettie & Malaghan LLC, Groton, Connecticut as the Town's Auditor for FY 23/24. A. O'Neill seconded the motion. Discussion: none. Voting in favor: R. Rimmer, A. Stirna, M. Couture, T. Amatrudo, S. O'Brien, and, A. O'Neill. Opposed: none. Abstentions: none. The motion was **carried**, 6-0-0.

Status: 2019/2020, 2020/2021 and 2021/2022 Annual Reports. The Reports are not available at this time. R. Rimmer will follow up on these.

Discussion Re: PFAS Status. There was a general discussion on the need to gather data on possible costs.




