MINUTES

Regular Meeting September 12, 2023

Chairman Robert Rimmer called the September 12, 2023 Regular Meeting of the Board of Finance of the town of Killingworth to order at 7:00 P.M. in the Front Meeting Room of the Town Office Building, 323 Route 81, Killingworth, Connecticut.

Discussion with Killingworth Volunteer Fire Company Representative

Present for the Killingworth Volunteer Fire Company Rick Darin, Chief Ethan Darin. Assistant Chief Damon Manz, Chief Engineer and Todd Hajek, Senior Trustee

Chief Rick Darin thanked the Board for the support of their budget and the support from the Town Hall Staff.

With input from the other members present, he gave an overview of the type of calls for assistance they receive and the response to same, including mutual aid calls. Their focus now is on training and recruitment. The fire prevention program will be re-instated and member in-house training which were discontinued during Covid.

He noted that last year's operating expenses came in on target with their budget which included unanticipated major expenses for unanticipated repairs, discovered during a routine maintenance review, that had to be performed to keep an apparatus on the road. Anticipated expenses for the coming operating budget will include an increase in administrative support which is needed due to the increased required documentation for apparatus, training, equipment and supplies inventory, apparatus and facility maintenance.

As to their capital budget, he noted that they are still waiting for the new rescue truck to be delivered. RFQs, developed with help from Selectman Louis Annino, have gone out for the needs assessment of the current Department and facilities and their future needs. A committee has been established for apparatus replacement. There is a need for upgrading the current radio system to allow the Town to fully equip members with radios that are capable of communicating with other Towns during mutual aid events. This is a State system that local fire agencies can join. Currently Killingworth has a small number of members that have the radios in addition to radios installed in some/all apparatus. The goal is to outfit each member with the radios.

They then addressed inquiries of the Board. The Board recommended that when the Fire Company prepares their future budgets, they indicate how some of their donated funds and/or donated equipment are used to offset some of their expenses that benefit the safety of the public, which result in a savings to the taxpayers.

Reports:

<u>First Selectwoman Nancy Gorski</u>. She was not present but distributed her written comments for consideration. They were reviewed.
