OLD BUSINESS

- **Jack B. Coy, LLC (owner), Michael Berkun (applicant) - permit application
Property between Roast Meat Hill Road and Reservoir Road
Four farm sheds**

The Commission has not received any notice that the property is ready for a site walk with stakes put in as requested. Enforcement Officer L. Kieft-Robitaille will contact the applicant again.

In addition, Chairman Johnson noticed a breach in the silt fence and notified the applicant who repaired it.

- **99 River Road, Ryan Sweeney, applicant/owner: Discussion of any wetlands violations and remediation**

Applicant is working on drainage for culvert and plunge pool. Chairman Johnson noted that he will be cleaning the culvert and he recommends adding gabion basket to the plunge pool. Chairman Johnson will suggest that the Applicant use the gabion baskets instead of the concrete barrier on plans.
