MINUTES

T. Doyle moved, seconded by C. Plum, to approve the minutes of the January 14, 2025 Regular Meeting. The motion carried unanimously.

OLD BUSINESS

- **Jack B. Coy, LLC (owner), Michael Berkun (applicant) - permit application
Property between Roast Meat Hill Road and Reservoir Road. Four farm sheds**
T. Doyle moved, seconded by E. Pizzuto, to table this item until next meeting. The motion carried unanimously.
- **Application W-39 Amato Bevilaqua, owner/Aquatic Pool & Spa applicant.
Construct 18'x38' pool with heater in upland review area.**
T. Doyle moved, seconded by C. Plum, to approve the application with a silt fence protection during pool construction. The motion carried unanimously.
- **99 River Road, Ryan Sweeney, applicant/owner: Discussion of any wetlands violations and remediation**
The letter proposed at the last meeting was sent and received by suggest that the applicant to use gabion baskets instead of the concrete barrier on plans. Currently the applicant is waiting for the weather to permit commencement of hydroseeding.

- **11 Colonial Dr. Ernest & Michele Pizzuto**

Construct 14' addition to existing barn

Applicant would like to add an extension to the existing barn for boat storage. The site plan is sufficient for the commission to determine approval.

- **104 Parker Hill Rd. Ext. Peter & Michelle Compstone**

Discussion regarding repairing approved 40yr. old culverts for driveway over Heft Brook.

The farm driveway, which provides farming access, has 48" culvert pipes which are rusting and the applicant would like to change them. This is an as of right farm activity.

- **Wetlands Appeal of Jack B Coy LLC M. 29 L.59A Roast Meat Hill Rd.**

T. Doyle moved, seconded by C. Plum, to approve the motion for withdrawal of the appeal of Jack B. Coy, LLC, being Docket No. MMX-CV24-6042905-S pending in the Superior Court for the Judicial District of Middlesex at Middletown. Approval of the withdrawal is required by Connecticut General Statutes Section 22a-43(d) and Connecticut Practice Book Section 14-7B. The motion carried unanimously.
